#### **ORDINANCE NO. 2023-12-02**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF QUINLAN, TEXAS, AMENDING APPENDIX A, FEE SCHEDULE, SECTION A6.010 SOLID WASTE COLLECTION AND DISPOSAL FEES OF THE CITY OF QUINLAN CODE OF ORDINANCES, GARBAGE AND REFUSE COLLECTION FEES; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR EFFECTIVE DATE.

**WHEREAS**, the City Council of the City of Quinlan desires to provide quality solid waste collection services to the citizens and customers of the City of Quinlan at reasonable and fiscally responsible cost; and

**WHEREAS,** the City of Quinlan has approved an amended contract with Sanitation Solutions to continue to provide these services on behalf of the City, to implement a polycart program and to adjust rates as prudently as necessary to accommodate the delivery of these services; and

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUINLAN, TEXAS:

#### SECTION 1: Amendment.

THAT, Appendix A, Fee Schedule, Section A6.010 Solid Waste Collection and Disposal Fees of the City of Quinlan Code of Ordinances be amended as follows:

Each subscriber to the city's solid waste collection and disposal system shall pay monthly fees as listed below. Rates do not include state sales and use tax.

#### SECTION 2: Savings, Severability and Repealing Clauses.

The City declares that it would have passed this ordinance, and each section, subsection, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional or invalid.

# SECTION 3: Publication of the Caption Hereof and Effective Date.

This ordinance shall be in full force and effective from and after its passage and upon the posting and/or publication, if required by law, of its caption and the City Secretary is hereby directed to implement such posting and/or publication.
